SCHEDULE OF BASE END-USER TARIFFS APPLICABLE FOR THE SUPPLY OF ELECTRICITY BY UMEME LIMITED FOR THE YEAR 2022

NOTICE is hereby given that pursuant to Sections 10 and 75 of the Electricity Act, 1999, (Chapter 145 of the Laws of Uganda) the Electricity Regulatory Authority ("the Authority") has approved a Schedule of 2022 Base Electricity End-user Tariffs to be charged by Umeme Limited for the supply of electrical energy in the Billing Period January to March 2022, as detailed in **Table 1**.

The approved Base Electricity End-User Tariffs for 2022 represent a weighted average reduction of 1.0 percent relative to the Tariffs of the Fourth Quarter of 2021.

The approved Base Electricity Tariffs shall be subject to quarterly adjustments for changes in International prices of fuel, Exchange rate, Inflation and the Generation mix. The parameters used in the determination of the 2022 Base Tariffs are as detailed in **Table 2**.
